Ordinances Adopted by the Board of Supervisors of Santa Cruz County, California

Boundaries of the Precincts for the Great Register and Election of 1890

The Board of Supervisors of Santa Cruz County established Precincts by Ordinance.

The first Ordinance, **Number 43**, was adopted on September 8, 1888; and published by the *Santa Cruz Daily Sentinel* on October 4, 1888.

It was Amended by Ordinance **Number 46**, on September 24, 1888; and published by the *Santa Cruz Daily Surf* on October 6, 1888.

It was Amended by Ordinance **Number 74** on May 6, 1890; and published by the *Santa Cruz Daily Surf* on May 8, 1890.

It was Amended by Ordinance **Number 83** on August 13, 1890; and published by the *Santa Cruz Daily Sentinel* on August 27, 1890.

There was a subsequent Amendment on December 2, 1890, but it did not have an effect on the Election of November 4, 1890.

Other changes took place by Ordinances No. 124 (May 4, 1896), and subsequently by 141, 143, 159, 161, 182, 197, 213, and 214.

Voting Precincts.

[**Ordinance No. 43**: 8th day of September, 1888]

The following are the voting precincts of Santa Cruz county as established by the Board of Supervisors:

APTOS ELECTION PRECINCT. 43
(Soquel Township.)

Begins at the northeast corner of the Rancho San Andreas, being also the corner of San Andreas Precinct, and runs thence northerly along the westerly boundary of the Rancho Corralitos to the southwest corner of the "Moss 17-Acre Tract," of the Corralitos Rancho; thence northerly along the southerly boundary of said tract to the county road; thence northeasterly in a direct line across the lands of Charles Moss to the northwest corner of the lands of Swarthout; thence northeasterly along the boundary of the lands of Swarthout to the southeast corner of the "McLaughlin 233-acre Tract;" thence northerly along the easterly boundary of said McLaughlin tract, lands of Daniel Morgan and lands of one Hussey, to the northerly boundary of the Rancho Corralitos; thence westerly along the northerly boundary of said Rancho to the

easterly boundary of the Soquel Augmentation Rancho; thence northerly along said easterly boundary to the top of the ridge on the north side of the "Sweet Prairie;" thence southwesterly along the low divide between the Aptos and the Valencia creeks to a point where the southeasterly boundary of lot No. 9 of the Soquel Augmentation Rancho leaves said divide; thence southerly along the boundaries of lots 9 and 8 of said last named Rancho, to the north boundary of the Aptos Rancho; thence westerly along the northerly boundary of said Rancho to the northwest corner thereof; thence southerly along the westerly boundary of said Rancho to the bay of Monterey; thence southeasterly along said bay to the southwesterly corner of the Rancho San Andreas, and thence following the boundary of the San Andreas Rancho, first northeasterly and then easterly, to the northeast corner of said Rancho, being the place of beginning.

BEN LOMOND ELECTION PRECINCT, NO. 1. 43
(Santa Cruz Township.)

Beginning on the easterly side of the road known as the Empire Grade, near the N W corner of the Rancho Canada del Rincon, at a point where said road intersects the north boundary of Sec. 29, T10S, R2W; thence W. along the north boundary of Section 29 and 30 to the northwest corner of Sec. 30; thence south along the township line one-half mile; thence west one-quarter mile; thence west one-quarter mile; thence south to the north boundary of the Rancho Arroyo de la Laguna; thence westerly along said boundary to easterly boundary of the Rancho San Vicente to the San Vicente Creek; thence northerly up the middle of San Vicente creek to the intersection with the north line of T10S, R3W; thence due W and across the San Vicente Rancho to the N E corner of Section 6, T10S, R3W; thence due north two miles to the N E corner of Section 30, T9S, R3W; thence due W. three miles to the S.W. corner of Section 23, T9S, R4W; thence due N two miles to the S W corner of Section 11, T9S, R4W; being also the corner of San Lorenzo township; thence due E five miles to the SE corner of Section 9, T9S, R3W; thence S one mile to the S W corner of Section 15, T9S, R3W; thence E one mile to the SE corner of Section 15, T9S, R3W; thence S half a mile to the quarter section stake on the W boundary of Sec. 23, T9S, R3W; thence E half a mile to the center of Sec. 23, T9S, R3W; thence S one quarter of a mile; thence E half a mile to the eastern line of said Sec. 23; thence S three-quarters of a mile to the quarter section stake on the W boundary of Sec. 25, T9S, R3W; thence E one-quarter of a mile; thence S one-quarter of a mile; thence E one-quarter of a mile; thence S one quarter of a mile to the quarter section stake on the S boundary of Sec. 25, T9S, R3W; thence E half a mile to the S E corner of said Sec. 25; thence S along the township line to the N W corner of Sec. 27, T10S, R2W; thence E half a mile to the quarter section stake on the N line of said Sec. 7; thence S half a mile to the center of said Sec. 7; thence E one quarter of a mile; thence due S to the intersection of the E side of the road known as the Empire Grade; thence southerly along the easterly side of said Empire Grade; thence southerly along the easterly side of said Empire Grade to its intersection with north line of Sec. 29, T10S, R2W, the place of beginning.

BEN LOMOND ELECTION PRECINCT, NO. 2. 43
(San Lorenzo Township.)

Beginning at the northwest corner of Section 35, T9S, R2W, and runs thence west on the section line to the west line of T9S, R2W; thence south on the line between ranges 2 and 3 west, to the northwest corner of Section 7, T10S, R2W; thence east

one-half mile; thence south one-half mile; thence east one-quarter mile; thence south to the north line of said Section 7; thence east along the section line and the produced line thereof to a point on the Zayante Rancho one mile south of the one-quarter section post on the north boundary of Section 10, T10S, R2W; thence north to the north boundary of the Zayante Rancho; thence east to the east boundary of said Section 10; thence north between Sections 10 and 11, 2 and 3, 34 and 35, to the place of beginning.

BRANCIFORTE ELECTION PRECINCT.

(Branciforte Township)

Begins on the bay of Monterey at the easterly line of the city of Santa Cruz and runs thence northerly along the easterly line of said city to the northeast corner thereof; thence along the middle of the west branch of the Branciforte creek to the south boundary of the San Augustine Rancho; thence easterly along said boundary to the southeast corner thereof; thence northerly along the easterly boundary of said Rancho to its intersection with the north line of Section 30, T10S, R1W; thence due east to the quarter section stake on the north boundary of Section 29, T10S, R1W; thence due north half a mile to the center of Section 20, T10S, R1W; thence due east one-quarter of a mile; thence due north half a mile to the north line of said Section 20; thence due east one-quarter of a mile to the northeast corner of said Section 29; thence due north half a mile to the quarter section stake on the west boundary of Section 16, T10S, R1W; thence due east half a mile to the center of said Section 16; thence due north one mile to the center of Section 9; thence due east three-quarters of a mile to the east boundary of Branciforte Township; thence along said boundary south one-half mile; thence west one-quarter of a mile to the northeast corner of Section 16; thence south two miles to the northeast corner of Section 28; thence east one-quarter of a mile; thence south two miles to the line separating townships 10 and 11 S, R1W; thence west to the east side of the Rodeo Gulch road; thence southerly along the east side of said road to the north side of the Santa Cruz and Watsonville road; thence westerly to the middle of Rodeo Gulch; thence southerly down said gulch to the bay of Monterey, and thence westerly along said bay to the place of beginning.

BOULDER CREEK ELECTION PRECINCT.

(San Lorenzo Township)

Begins at the northwest corner of Section 31, T9S, R2W, and runs thence east three and one-half miles to the quarter section stake on the north line of Section 34, Township 9 S, R2W; thence north along the quarter section line dividing Sections 27, 22, 15, 10 and 3, T9S, R2W, to the quarter section stake on the north boundary of Section 3, T9S, R2W; thence due west along the township line two and one-half miles to the N W corner of Section 5, T9S, R2W; thence due north along the west boundary of Sections 32, 29, 20, 17 and 8, T8S, R2W, to the northerly line of Santa Cruz county; thence northwesterly along said county line to the northerly corner of Santa Cruz county; thence south and along the line of San Mateo county to the northeast corner of Section 26, T8S, R3W; thence continuing along the line of San Mateo county due west to the north-west corner of Section 30, T8S, R3W; thence continuing along said county line south, to the south-west corner of Section 31, T8S, R3W; thence due west two miles to the northwest corner of Section 2, T9S, R4W; thence due south two miles to the southwest corner of Section 11, T9S, R4W; thence east five miles to the southeast corner of Section 9, T9S, R3W; thence south 1 mile to the southwest corner of Section 15, T9S, R3W; thence east one mile to the southeast corner of said Section

15; thence south half a mile to the quarter section stake on the west line of Section 23, T9S, R3W; thence east half a mile to the center of said Section 23; thence south one-quarter mile; thence east half a mile to the east line of said Section 23; thence south three-quarters of a mile to the quarter section stake on the west line of Section 25, T9S, R3W; thence east one-quarter of a mile; thence south one-quarter of a mile, thence east one-quarter of a mile, thence south one-quarter of a mile to the quarter section stake on the south line of Section 25, T9S, R3W; thence east half a mile to the southeast corner of Section 25, the place of beginning.

CORRALITOS ELECTION PRECINCT. 43
(Pajaro Township)

Begins at the intersection of the San Andreas and Freedom roads with the road leading from Santa Cruz to Watsonville, and runs thence westerly along the road from Santa Cruz to Watsonville to the easterly corner of the "Moss 17 acre Tract;" thence northeasterly in a direct line across the lands of Chas. Moss to the northwest corner of the lands of one Swarthout; thence northeasterly along the boundary of lands of Swarthout to the southeast corner of the McLaughlin 233 acre tract; thence northerly along the easterly boundary of said "McLaughlin trace," lands of Daniel Morgan and lands of one Hussey to the north boundary of the Rancho Corralitos; thence westerly along the northerly boundary of said Rancho to the easterly boundary of Soquel Augmentation Rancho; thence northerly along the easterly boundary of said last named Rancho to the county line; thence southeasterly along the county line to the road that leads from Watsonville to San Jose, being the corner of Watsonville Precinct No. 1; thence along said road southerly to the road that connects said Watsonville and San Jose road with the Green Valley road; thence westerly along said connecting road to the Green Valley road; thence westerly along said Green Valley road and the road which leads to Sandy's Corners to the northwest corner of the land of Bishop Mora; thence southerly along the westerly boundary of said Mora's land to the land of Ford and others thence westerly along the northerly boundary of said last named tract to the northeast corner of the McKinley tract; thence southerly along the easterly boundary of the McKinley tract to its southeast corner in Corralitos Creek; thence in a direct line southwesterly to the intersection of the Santa Cruz and Watsonville road with the San Andreas and Freedom road, said intersecting point being the place of beginning.

DAVENPORT ELECTION PRECINCT. 43
(Santa Cruz Township)

Begins at the northwest corner of Section 2, T9S, R4W, on the line between Santa Cruz and San Mateo counties; and runs thence south 4 miles to the southwest corner of Section 23, T9S, R4W; thence east 3 miles; thence south 2 miles to the township line; thence east along the township line to the middle of San Vicente creek; thence southerly along the middle of said creek to the Pacific Ocean, being also on the southerly line of Santa Cruz county, and thence following said line (first) northwesterly, then northerly and then east to the place of beginning..

FELTON ELECTION PRECINCT. 43
(San Lorenzo Township)

Begins on the easterly boundary of the Rancho Canada del Rincon at the corner of the Ranchos San Augustine and Carbonero at the spring, and runs thence N along the E boundary of the Rancho Canada del Rincon to its northeast corner on the westerly

boundary of the Rancho San Augustine; thence N along the W boundary of the Rancho San Augustine to its intersection with the easterly line of Section 14, T10S, R2W; thence north to the S W corner of the northwest quarter of the northwest quarter of Section 12, T10S, R2W; thence east one-quarter mile; thence north one half of a mile; thence east three-quarters of a mile to the west boundary of Section 6, T10S, R1W; thence north one mile to the Township corner 9 and 10 south, Ranges 1 and 2 west; thence east one-half mile; thence north one-half mile to the middle of Section 31, T9S, R1W; thence east one-half mile; thence north one-half mile to the northeast corner of said Section 31; thence west three miles to the northwest corner of Sec. 35, T9S, R2W; thence south to the north boundary of the Zayante Rancho; thence west one-half mile to the one-quarter section line through Section 10, north and south; thence south to the south boundary of Section 10, thence west along the south boundaries of Sections 10, 9, 8 and 7 to the southwest corner of the east half of the southeast one-quarter of Section 7; thence south to the east side of the road known as the Peterson grade; thence southerly along the east side of said road to the line produced westerly of the Thompson survey of the north boundary of the Carbonero rancho, the same being the northwesterly corner of the Powder Mill Precinct, and thence easterly along said line to the place of beginning.

The following are the voting precincts of Santa Cruz county as established by the Board of Supervisors:

GLENWOOD ELECTION PRECINCT. 43
(Branciforte Township)

Beginning on the easterly line of Branciforte Township, where the same is intersected by the east and west line through Sec. 10, T10S, R1W; thence west to the middle of Section 9 of said township and range; thence south one-half a mile to the north boundary of Section 16; thence west to the east boundary of the San Augustine Rancho; thence westerly and northerly around the lands of J. N. Luff and L. Kloss to the northerly line of said rancho; thence westerly along said last named line to the line running north on the west boundary of Sec. 8, T10S, R1W; thence north along said last named line to the northwest corner of said Section 8; thence west along the line between Sections 6 and 7 to the west line of T10S, R1W; thence north along said last named township line to its intersection with the west line of Branciforte Township; thence along the west line of Branciforte Township northerly to the country boundary; thence continuing easterly along said county boundary and the boundary of said township to the east side of the San Jose road; thence south westerly along the easterly side of said road to its intersection with the east line of Sec. 20, T9S, R1W; or the produced line thereof northerly; thence south along said line to its intersection with the north boundary of the Soquel Augmentation Rancho; thence westerly along said boundary to the northwest corner of said rancho; thence southeasterly along the west boundary of said rancho to the northwest corner of lands of C. C. Martin; thence easterly, southerly and westerly around the lands of said Martin, and including the same, to the aforesaid westerly boundary of Soquel Augmentation Rancho; thence

southeasterly along said boundary to the line separating Townships 9 and 10 south, range 1 west; thence west to the northeast corner of the west one-half of the northwest one quarter of Sec. 3, T10S, R1W; thence south one and one-half miles to the place of beginning.

HIGHLAND ELECTION PRECINCT. 43
(Soquel Township)

Beginning on the west boundary of Soquel Township, at the northeast corner of the west $\frac{1}{2}$ of the northwest $\frac{1}{4}$ of Sec. 15, T10S, R1W; thence east to the westerly line of the Soquel Augmentation Rancho; thence in a direct line easterly to the top of the divide between Hinckley and Soquel creeks opposite the head of the west branch of Aptos creek; thence northerly and easterly following said divide to the easterly boundary of the Soquel Augmentation Rancho, thence northerly along the easterly boundary of said rancho, being also along the westerly boundary of Pajaro township to the county line; thence northwesterly along said county line to its intersection with the easterly side of the road from Santa Cruz to San Jose through Scott's Valley; thence southwestwardly along the easterly side of said road to its intersection with the east line of Sec. 20, T9S, R1W, or the produced line thereof northerly; thence south along said section line to its intersection with the northern boundary of the Soquel Augmentation Rancho; thence westerly to the northwest corner of said rancho; thence southerly along the westerly boundary of said rancho to the northwest corner of the lands of C. C. Martin; thence easterly, southerly and westerly around the lands of said Martin, and excluding the same, to the aforesaid westerly boundary of the Soquel Augmentation Rancho; thence southeasterly along said boundary to the line separating Townships 9 and 10 south, range 1 west; thence west to the northeast corner of the west half of the northwest quarter of Sec. 8, T10S, R1W, and thence south to the place of beginning.

LAGUNA ELECTION PRECINCT. 43
(Santa Cruz Township)

Beginning on the westerly boundary of the city of Santa Cruz, at the southeast corner of lot 8 of the Davis & Cowell tract, as shown on the map in the office of the County Recorder of Santa Cruz county, June 2d, 1880; thence westerly following along the southerly boundary of said Davis & Cowell's land, as shown on said map, to the easterly boundary of the tract of land heretofore known as the Almstead Tract; thence north along the easterly boundary of said tract and of lands known as the Gushee Tract to the northeast corner of said Gushee Tract; thence west to the middle of the Laguna creek; thence northerly up the middle of said creek to the north boundary of the Refugio Rancho; thence westerly along the north boundary of said rancho and of the Rancho Arroyo de Laguna to the middle of the San Vicente creek; thence southerly down said creek, the same being the boundary of the San Vicente Rancho, to the Pacific Ocean; thence easterly along the ocean boundary of the city of Santa Cruz, and thence north along said boundary to the place of beginning.

LIME KILN ELECTION PRECINCT. 43
(Santa Cruz Township)

Beginning on the westerly boundary of the city of Santa Cruz, at the southeast corner of lot 8 of the Davis & Cowell Tract, as shown on map filed in the office of the County Recorder of Santa Cruz county, June 2d, 1880; thence westerly following along

the southerly boundary of said Davis & Cowell's land, as shown on said map, to the easterly boundary the tract of land heretofore known as the "Almstead Tract;" thence north along the easterly boundary of said tract of land and of lands known as the Gushee Tract to the northeast corner of the said Gushee Tract; thence west to the middle of Laguna creek; thence northerly up the middle of said creek to the north boundary of the Refugio Rancho; thence westerly along said boundary and the boundary of the Rancho Arroyo de Laguna to the west boundary of lot 5 of Section 36, T10S, R3W; thence north to the quarter section line through Sections 25, east and west; thence east one-quarter of a mile to the east boundary of Section 25; thence north one-half mile to the northwest corner of Section 30, T10S, R2W; thence east along the north boundary of Sections 30 and 29 to the east side of the Peterson road, and thence southerly along the easterly side of said Peterson road to the place of beginning.

POWDER MILL ELECTION PRECINCT. 43
(San Lorenzo Township)

Begins in the middle of San Lorenzo river on the northerly line of the city of Santa Cruz, and runs thence easterly along said city line to the easterly side of the East San Lorenzo road; thence northerly along the easterly side of said road to its intersection with the line of the "Thompson Survey" of the Carbonero Rancho; thence westerly along said line of said survey and the produced line thereof to the continuation of the Empire Grade known as the "Peterson road"; thence southerly along the easterly side of the Peterson road to its intersection with the westerly line of the city of Santa Cruz; thence north to the northwest corner of said city, and thence easterly along the northerly line of said city to the place of beginning.

SAN ANDREAS ELECTION PRECINCT. 43
(Soquel Township)

Begins on the Bay of Monterey at the southeast point of the land owned by **Manuel Silva**, said land being "Lot No. 3," of Hale's subdivision of "Lot No. 24" of the San Andreas Rancho, and runs thence northeasterly along the easterly boundary of said Silva's land and the land of one **Sullivan** to the county road; thence in a direct line northeasterly towards the southeast corner of the lands of **Abraham Cox** to the land of the Santa Cruz R. R. Co.; thence easterly along the southerly side of the land of said railroad company to the boundary line between the Ranchos San Andreas and Corralitos; thence northerly along the boundary line between said ranchos to "Post S. A. No. 6," of the San Andreas Rancho, near the head of the slough; thence leaving said boundary line to and along the slough to "Post S. A., No. 5," of the San Andreas Rancho, which post stands on the northerly side of the San Andreas and Freedom roads; thence continuing northerly along the boundary line between the Ranchos San Andreas and Corralitos to the northeast corner of the San Andreas Rancho; thence westerly along the northerly boundary of the San Andreas Rancho to its northwesterly corner; thence southwesterly along the northwesterly boundary of said rancho to the Bay of Monterey; thence southeasterly along said bay to the place of beginning.

LOMA PRIETA ELECTION PRECINCT. 43
(Soquel Township)

Beginning at the northwest corner of the Aptos Rancho; thence northerly along the west boundary of Lot 8 of the Soquel Augmentation Rancho as the same is laid down on the partition map of said rancho, and along the divide between the Bates and Aptos creeks to the corner of Lot No. 10 of said rancho; thence continuing along said divide northerly and across said Lot No. 10 to a corner on Lot No. 9 of said rancho; thence westerly leaving said divide to the corner of Lot No. 27 of said rancho; thence (first) southerly and then westerly along the boundary of said Lot No. 27 to the divide between Hinckley and Soquel creeks; thence northerly and easterly following said divide to the easterly boundary of the Soquel Augmentation Rancho; thence southerly along said boundary to the low divide between Aptos and Valencia creeks; thence southwesterly along said low divide to a point where the southeasterly boundary of Lot No. 9 of said rancho leaves said divide; thence southerly along the boundaries of Lots Nos. 9 and 8 of said rancho to the north boundary of the Aptos Rancho, and thence along said last named boundary westerly to the place of beginning.

SANTA CRUZ ELECTION PRECINCT, NO. 1. 43
(Branciforte Township)

Begins on the Bay of Monterey at the middle of Pacific avenue, and runs thence northerly along the middle of Pacific avenue to its intersection with the middle line of Water street; thence along the middle line of Water street to the middle of the San Lorenzo river; thence northerly up the middle of the San Lorenzo river to its intersection with the northerly boundary of the city of Santa Cruz; thence easterly along the northerly boundary of the city of Santa Cruz to the northeast corner of said city; thence southerly along the easterly line of said city to the Bay of Monterey, and thence westerly along said bay to the place of beginning.

SANTA CRUZ ELECTION PRECINCT, NO. 2. 43
(Santa Cruz Township)

Beginning in the city of Santa Cruz at the intersection of the middle line of Pacific avenue with the middle line of Walnut avenue; thence along the middle line of Walnut avenue westerly to the easterly side of Mission street; thence along the easterly side of Mission street southwesterly to the westerly boundary of Santa Cruz; thence northerly along the westerly boundary of said city to the easterly side of the continuation of the Empire Grade, known as the Peterson road; thence southerly along the easterly side of the said Peterson road to its intersection with High street in the city of Santa Cruz; thence easterly along the middle of High street to its intersection with the westerly boundary of the Rancho Tres Ojos de Agua; thence southerly along the westerly boundary of the Rancho Res Ojos de Agua and along the middle of Mill street to the middle of Mission street; thence northeasterly along the middle of Mission street to the middle of Pacific avenue and down the middle of Pacific avenue to the place of beginning.

SANTA CRUZ ELECTION PRECINCT, NO. 3. 43
(San Lorenzo Township)

Begins in the middle of Pacific avenue at its intersection with the middle of Water street, in the city of Santa Cruz, and runs thence easterly along the middle of Water street to the middle of the San Lorenzo river; thence northerly up the middle of the San Lorenzo river to the northerly boundary of the city of Santa Cruz; thence westerly along the northerly boundary of the city of Santa Cruz to the northwest corner of said city; thence south along the west boundary of said city to the easterly side of the continuation of the Empire Grade, known as the Peterson road; thence southerly along the easterly side of the said Peterson road to its intersection with High street in the city of Santa Cruz; thence easterly along the middle of High street to its intersection with the westerly boundary of the Rancho Tres Ojos de Agua; thence southerly along the westerly boundary of the Rancho Tres Ojos de Agua and along the middle of Mill street to the middle of Mission street; thence northeasterly along the middle of Mission street to the middle of Pacific avenue, to the place of beginning.

SANTA CRUZ ELECTION PRECINCT, NO. 4. 43
(Santa Cruz Township)

Beginning at the Bay of Monterey, in the middle of Pacific avenue, in the city of Santa Cruz; thence northerly along the middle line of Pacific avenue to its intersection with the middle line of Walnut avenue; thence along the middle line of Walnut avenue westerly to the easterly side of Mission street; thence southwestly along the easterly side of Mission street to the westerly boundary of the city of Santa Cruz; thence southerly along said boundary to the Bay of Monterey, and thence easterly along said bay to the place of beginning.

SCOTTS VALLEY ELECTION PRECINCT. 43
(Branciforte Township)

[Ordinance No. 83: 13th day of August, 1890]

To Amend the Sections (Establishing the Boundaries of Boulder Creek, Branciforte, Santa Cruz Nos. 1, 2 and 4, Summit, Soquel and Watsonville Nos. 1 and 2, Election Precincts) of Ordinance No. 43, Entitled "An Ordinance Establishing Election Precincts in the County of Santa Cruz," Passed September 8th, 1888, and Change the Boundaries of Said Precincts so as to Create 7 New Precincts and Name and Designate the Same Respectively, Branciforte No. 1, Castle Rock, Santa Cruz Nos. 5 and 6, Sequoia, Soquel No. 2 and Watsonville No. 5, Election Precincts.

Beginning on the northeast boundary of the city of Watsonville, in the middle of Fourth street; thence northwesterly along the northeasterly boundary of said city to its northerly corner; thence southwesterly along the northerly boundary of said city to its westerly corner; thence southeasterly along the southwesterly boundary of said city to a point on the middle line of the aforesaid Fourth street produced, southwesterly to the aforesaid boundary of said city and thence northeasterly along the said produced line to and along the middle line of said Fourth street to the place of beginning.

This ordinance shall take effect and be in force from and after the expiration of fifteen days after its passage and approval, and before the expiration of the said fifteen days the same shall be published for at least one week in the SANTA CRUZ DAILY SENTINEL. All ordinances and orders heretofore passed in conflict with this ordinance are hereby repealed.
